I, ALFRED RUSSEL WALLACE of Old Orchard Broadstone in the County of Dorset Esquire O.M., L.I.D., D.C.L., Hereby revoke all former Wills and Testamentary Dispositions made by me and Declare this to be my last Will and Testament.

1. I APPOINT THE PUBLIC TRUSTEE constituted by the Public Trustee Act 1906 (hereinafter called my Trustee) to be the EXECUTOR and TRUSTEE of this my Will.
2. I GIVE AND BEQUEATH all my medals presented to me by Scientific Societies, the Insignia of the Order of Merit, my autograph letters, medallions, family portraits, and the Author's copy of each of my books unto my Wife Annie Wallace my daughter Violet Isabel Wallace and my son William Greenell Wallace to be held by them as joint tenants during their joint lives and to ultimately become the property of the survivor of them.
3. I DEVISE AND BEQUEATH all my plate linen china glass books pictures furniture and household effects (except the articles and things mentioned in Clause 2 hereof) unto my Trustee Upon Trust to allow my said Wife to use the same during her life and after her death to divide the same between my said, daughter and son in equal shares and in the event of there being any dispute as to such division I declare that my Trustee shall sell such effects and divide the proceeds equally between my said daughter and son Provided always that in the event of my said Wife wishing any of the said articles to be sold during her lifetime then my Trustee shall with the consent of my said daughter

and son sell the same and divide the proceeds into four equal parts and pay two of such parts to my said Wife for her own separate use and benefit one of such parts to my said daughter for her own separate use and benefit and the remaining one of such parts to my said son for his own use and benefit.

4. I DEVISE AND BEQUEATH my freehold messuage or dwelling-house known as Old Orchard Broadstone aforesaid unto my Trustee Upon Trust during the life of my said Wife to permit my said Wife daughter and son to reside therein if they or any or either of them shall collectively so desire but in the event of their not collectively so desiring then my said Wife shall be entitled to reside in the said premises during her life she paying all outgoings (including insurance premiums in respect thereof) and keeping the same in sufficient repair.

5. SUBJECT to Clause 4 hereof I declare that my said freehold messuage shall fall, into and form part of my residuary estate.

6. I DEVISE AND BEQUEATH all my real and personal estate not hereby otherwise disposed of (hereinafter called my said residuary estate) subject to and after payment out of my personal estate (or in case of deficiency thereof out of my real estate) of my funeral and testamentary expenses and debts unto my Trustee ~~according to the nature and tenure thereof~~ Upon Trust that my Trustee shall hold the same upon the following trusts:-

(a) During the life of my said Wife to pay to her one equal half part of the net income of my residuary estate and to divide the remaining one equal half part of such income equally between my said daughter and son.

(b) Subject to sub-clause (a) hereof to hold my said residuary estate Upon Trust for my said daughter and son in equal shares.

7. I DECLARE that my Trustee may be at liberty to retain any shares belonging to me in any undertaking for so long as he shall think fit without being responsible for any loss that may arise thereby.

8. I DECLARE that my Trustee shall be at liberty to let or demise any of my freehold or leasehold property from year to year or for any term of years at such rent and subject to such covenants and conditions as he shall think fit to accept surrenders of leases and tenancies to expend money in repairs and improvements and generally to manage the property according to his absolute discretion.

9. I DECLARE that my Trustee shall at any time with the consent in writing of my said Wife daughter and son or such of them as shall for the time being be living be at liberty to sell my residuary estate or any part or parts thereof either together or in lots and in such manner and subject to such terms and conditions as he shall think fit and shall invest the proceeds of such sale with power from, time to time to vary such investments and stand possessed of such investments upon the same trusts as are hereinbefore declared with regard to my said, residuary estate or instead of investing such proceeds (if all the persons entitled for the time being to my residuary estate under this my Will shall so direct in writing) shall divide the net proceeds of such sale into four equal parts and pay two of such parts to my said Wife for her own separate use and benefit one of such parts to my said daughter for her own separate use and benefit and the remaining one of such parts to my said son for his own use and benefit the moneys so divided to be held by the persons receiving the same respectively discharged from all the trusts of this my Will.

10. I DECLARE that all moneys liable to be invested under this my Will may be invested, in any of the public stocks or funds or Government securities of the United Kingdom or India

or in stock of the Bank of England or upon real or leasehold securities in England or Wales or in or upon, the preference stock or preference shares or debentures of any municipal or other Corporation Company or Public Body in Great Britain or Ireland or in any British Colony or Dependency or Foreign State.

11. I DECLARE that it is my wish that my Trustee shall from time to time consult my said Wife daughter and son or such of them as shall for the time being be living as to any matters that may arise in connection with the administration of my Estate including especially the payment of duties and the investment of any moneys liable to be invested under this my Will.
